

FINANCIAL STATEMENT FOR INTERNATIONAL STUDENTS

For many years, international students have been encouraged to apply for admission and to earn an undergraduate degree at Presbyterian College. Presbyterian College students, faculty, and staff delight in the cultural diversity which international students bring to the intellectual, spiritual, and cultural dimensions of campus life.

However, because of budget restrictions, financial assistance is often unavailable for international students admitted to the College. As a consequence, all international students intending to enroll at Presbyterian College must be able to bear most or all of the cost of attendance from their own resources.

In order to be eligible to receive an I-20 student visa, you will need to:

1. Apply for and be granted admission to Presbyterian College;
2. Show evidence, via the attached financial statement, that you and your family or sponsor have the resources to pay the cost of attendance which includes charges for housing, food, tuition, and fees.
3. Respond to a bill for the first term charges (and again to each bill for each term thereafter) with a certified check for the full amount minus any financial aid prior to attending classes at Presbyterian College.

Please review the attached form with your family and provide the information requested. The form must be signed by your parents and/or appropriate officials in order to be considered valid. An I-20 Visa will not be sent to you until this form has been received and the information on it verified.
