In this regard, I certify that I am covered by a 24-hour health and accident insurance policy.

I further covenant and agree that for the sole consideration stated above I will not sue the Institution, Board of trustees of Presbyterian College, its member individually, its officers, agents or employees for any claim for damages arising or growing out of my voluntary participation in recreational programs or athletic activities.
