| SC Life Scholarship | full time student, SC resident, and 2 out of 3 criteria: 3.0 GPA, top 30% of class, 1100 SAT or 24 ACT | Earn an average of 30 non-remedial credit hours by the end of each academic year(rising sophomore-30hrs, rising junior-60hrs, rising senior-90hrs; Earn a minimum 3.0 LIFE grade point average based on grades earned at ALL eligible SC institutions excluding remedial, continuing education, out-of- state and non-degree credit courses by the end of each academic year. |
| SC Hope Scholarship | first time freshman, full time student, SC resident, 3.0 GPA, is not eligible for the LIFE Scholarship | Non-renewable; See Life Renewal Requirements |
